

ORDINANCE NO. 2012-001

AN ORDINANCE AMENDING ORDINANCE 2006-013 (AN ORDINANCE REPEALING EXISTING ZONING ORDINANCES OF THE TOWN OF CRESTONE AND ENACTING NEW ZONING REGULATIONS FOR THE TOWN) AS AMENDED BY ORDINANCE 2009-009

WHEREAS, Ordinance 2006-013, as amended by Ordinance 2009-009, enacted comprehensive zoning regulations for the Town of Crestone and included regulations relating to “signs” in Regulation XI; and

WHEREAS, such sign regulations did not address “political signs”; and

WHEREAS, signs of a political nature are now being erected in the Town and the Town Board recognizes the necessity of appropriate regulations for such signs;

NOW THEREFORE, be it ordained by the Board of Trustees of the Town of Crestone, Colorado, that Ordinance 2006-013 (as amended by Ordinance 2009-0096) is amended to read as follows:

REGULATION XI: SIGNS

Sec. XI-5 Sign Categories and Size Limitations.

(j) Political signs are signs displayed on private property in accordance with an official election or erected on behalf of candidates for public office:

- 1) Signage may be displayed no more than 45 days prior to election day and no more than 10 days following election day.**
- 2) Signage may only be placed on private property and with the written permission of the property owner and shall not be placed in the public right-of-way.**
- 3) Signage in the commercial district shall not exceed 16 square feet total or 4 feet in height.**
- 4) Signage in the residential district shall not exceed 9 square feet total or 3 feet in height.**
- 5) Signage shall not be illuminated, animated, shall not flash, blink, fluctuate, etc., and shall not visually or physically obstruct, impede or block the flow of traffic or pedestrians on streets, sidewalks or trails or visually or physically obstruct a traffic control device.**

IT IS HEREBY DECLARED THAT THIS ORDINANCE IS NECESSARY FOR THE IMMEDIATE PRESERVATION OF PUBLIC PEACE, HEALTH AND SAFETY AND SHALL BECOME EFFECTIVE AND BE ENFORCED FROM AND AFTER PASSAGE OF THE SAME.

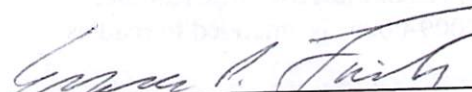
