

ORDINANCE NO. 2021- 003

AN ORDINANCE OF THE TOWN OF CRESTONE AMENDING THE CRESTONE
MUNICIPAL CODE TO INCLUDE THE OFFENSE OF PLACEMENT OF HOUSEWASTE
INTO TOWN AND PRIVATE PROPERTY WASTE RECEPTALS

WHEREAS, the Town Board of Trustees has become aware that individuals have begun disposing of their household waste into Town, business, and private property waste receptacles without authorization; and

WHEREAS, such practices creates additional expense for the Town as well as private business and residence owners; and

WHEREAS, the Offense Code of the Town (Chapter 13) presently forbids littering under Section 13-4-30.

NOW THEREFORE, be it ordained by the Board of Trustees of the Town of Crestone, Colorado, that Section 13-4-30 of the Crestone Municipal Code be amended to include the following subsection:

(c) It is unlawful for any person to throw or deposit any household waste or garbage into a container owned by the Town, a private business, or a private person without such owner's specific permission.

Any violation of this Ordinance shall be punishable under the general penalty section of the Crestone Municipal Code as described in Section 1-4-40.

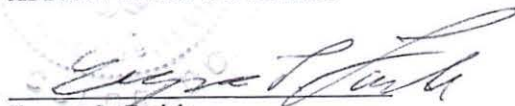

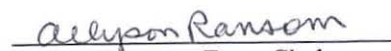

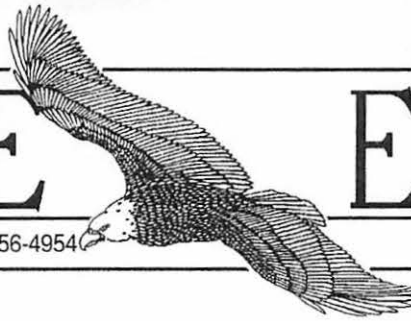
