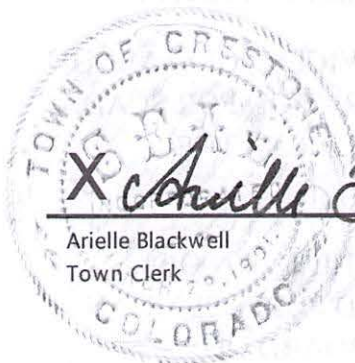
**Section 3. Legislative Intent.**
