AN ORDINANCE OF THE TOWN OF CRESTONE RENAMING THE FIRE PROTECTION FEES AS CONTAINED WITHIN THE CRESTONE MUNICIPAL CODE

WHEREAS, Section 7-1-30(1)(c) of the Crestone Municipal Code addresses "Fire Protection Fees" when the purpose of such section is to assess maintenance fees for the fire hydrants installed in the Town and which hydrants have to be maintained by the Public Works Department of the Town.

NOW THEREFORE, be it ordained by the Board of Trustees of the Town of Crestone, Colorado, that Section 7-1-30(1)(c) be amended to read as follows:

"(c) Fire Hydrant Maintenance Fees. In addition to the charges stated above, the annual fees are hereby levied for the purpose of fire hydrant maintenance within the Town..."
