

RESOLUTION

RE: Resolution designating a no shooting area.

WHEREAS, the residents of the unincorporated area near Crestone and the Baca Grande development have requested the Board of County Commissioners to designate the area shown in the attached Exhibit "A" as an area in which it is unlawful for any person to discharge firearms, and

WHEREAS, on September 7, 1982, the Board of County Commissioners of Saguache County held a public hearing, after proper notice (Attached as Exhibit "B"), at which hearing any and all interested persons had an opportunity to be heard. At said hearing the residents of the area to be designated expressed approval of the no shooting area as shown in the minutes of the public hearing which are attached as Exhibit "C", and

WHEREAS, the Board of County Commissioners finds that the area has a sufficient population density to meet the requirements of CRS 1973, 30-15-302 (2) as shown in the attached Exhibit "D", and

WHEREAS, THE Bureau of Land Management and U.S. Forest Service have approved of designating a no shooting area on public lands under their jurisdiction as shown in Exhibit "E", and

WHEREAS, the Board of County Commissioners finds that firearms as defined in CRS 1973, 30-15-301 (1) includes bows and arrows.

THEREFORE, be it resolved by the Board of County Commissioners of the County of Saguache, that the area shown in the attached Exhibit "A" is hereby designated as an area in which it is unlawful to discharge firearms, except a duly authorized law enforcement officer acting in the line of duty, or in shooting galleries, or in private grounds or residences only as provided for in CRS 1973, 30-15-302 (1).

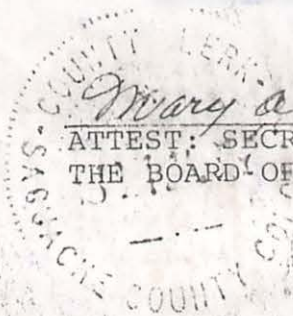
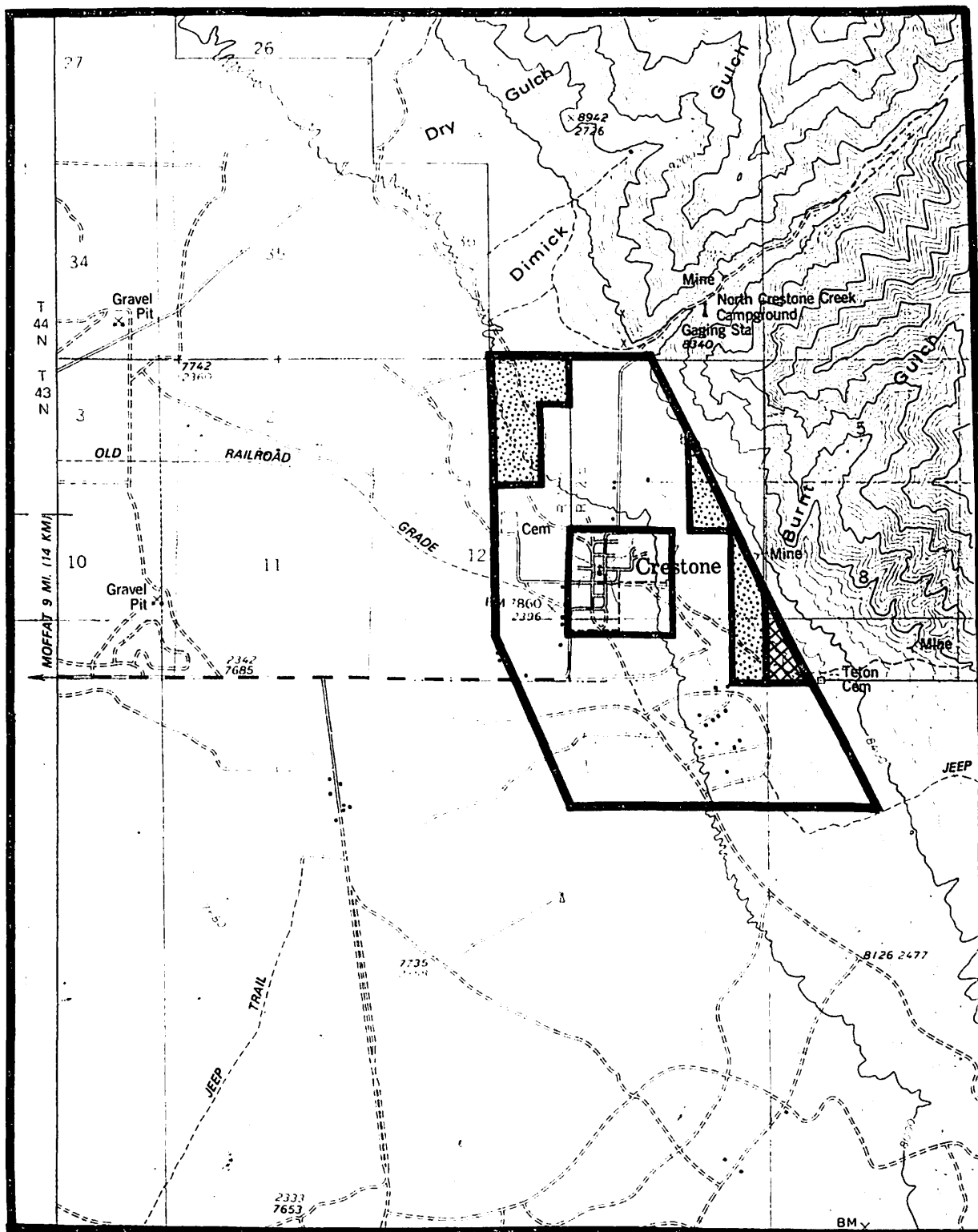

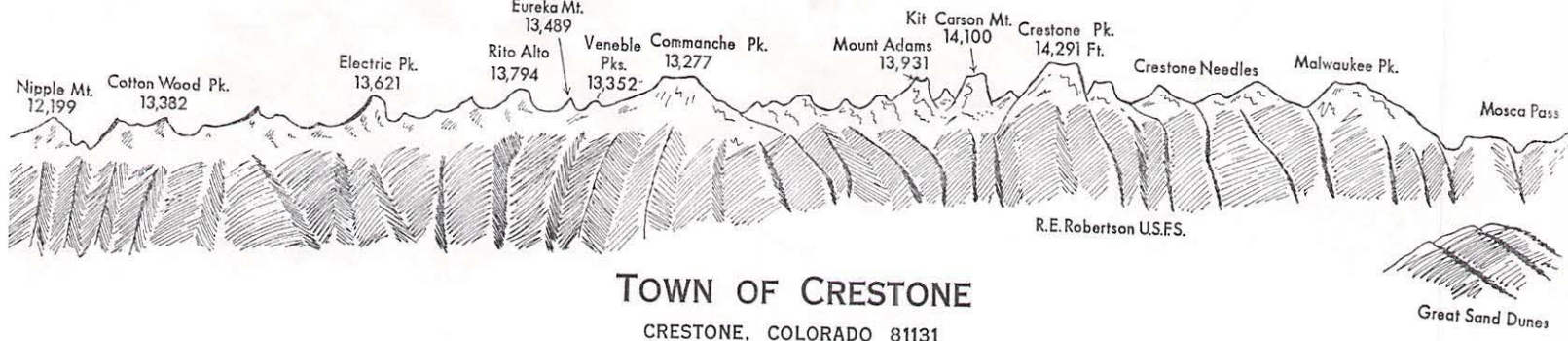
PRIVATE LAND

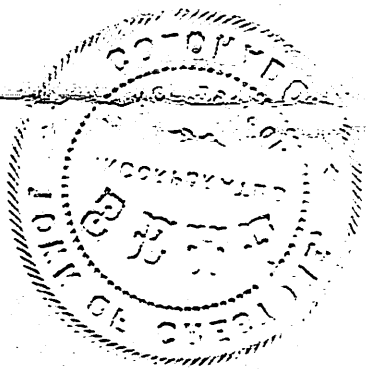
