

RESOLUTION TO ADOPT BUDGET

A RESOLUTION SUMMARIZING EXPENDITURES AND REVENUES FOR EACH FUND AND ADOPTING A BUDGET FOR THE TOWN OF CRESTONE, COLORADO, FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY, 1990, AND ENDING ON THE LAST DAY OF DECEMBER, 1990.

WHEREAS, the Town Council of Crestone has appointed Town Clerk to prepare and submit a proposed budget to said governing body at the proper time; and

WHEREAS, Town Clerk has submitted a proposed budget to this governing body on Nov., 1989, for its consideration, and;

WHEREAS, upon due and proper notice, published or posted in accordance with the law, said proposed budget was open for inspection by the public at a designated place, a public hearing was held on December 13, 1989, and interested taxpayers were given the opportunity to file or register any objections to said proposed budget, and;

WHEREAS, whatever increases may have been made in the expenditures, like increases were added to the revenues so that the budget remains in balance, as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF CRESTONE, COLORADO:

Section 1. That estimated expenditures for each fund are as follows:

Section 2. That estimated revenues for each fund are as follows:

Section 3. That the budget as submitted, amended, and hereinabove summarized by fund, hereby is approved and adopted as the budget of the Town of Crestone for the year stated above.

Section 4. That the budget hereby approved and adopted shall be signed by Mayor + Board Members made a part of the public records of the Town of Crestone.

RESOLUTION TO SET MILL LEVIES

A RESOLUTION LEVYING GENERAL PROPERTY TAXES FOR THE YEAR 1990, TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE TOWN OF CRESTONE, COLORADO FOR THE 1990 BUDGET YEAR.

WHEREAS, the Town Council of the Town of Crestone has adopted the annual budget in accordance with the Local Government Budget Law, on Dec. 13, 1989, and;

WHEREAS, the amount of money necessary to balance the budget for general operating expenses is \$, and;

WHEREAS, the amount of money necessary to balance the budget for bonds and interest is \$ 0, and;

WHEREAS, the amount of money necessary to balance the budget pursuant to Sections 29-1-301(1.2) and 29-1-302(1.5) for capital expenditures is \$ 0, and;

WHEREAS, the 1990 valuation for assessment for the Town of Crestone as certified by the County Assessor is \$ 265,450.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF CRESTONE, COLORADO:

Section 1. That the purpose of meeting all general operating expenses of the Town of Crestone during the 1990 budget year, there is hereby levied a tax of 7.599 mills upon each dollar of the total valuation for assessment of all taxable property within the Town of Crestone for the year 1990.

Section 2. That for the purpose of meeting all bonds and interest of the Town of Crestone during the 1990 budget year, there is hereby levied a tax of 0 mills upon each dollar of the total valuation for assessment of all taxable property within the Town of Crestone for the year 1990.

Section 3. That for the purpose of meeting all the Division of Local Government approved capital expenditures of the Town of Crestone during the 1990 budget year, there is hereby levied a tax of 0 mills when each dollar of the total valuation for assessment of all taxable property within the Town of Crestone for the year 1990.

Section 4. That the clerk is hereby authorized and directed to immediately certify to the County Commissioners of Saguache County, Colorado, the mill levies for the Town of Crestone as hereinabove determined and set.

RESOLUTION TO APPROPRIATE SUMS OF MONEY

A RESOLUTION APPROPRIATING SUMS OF MONEY TO THE VARIOUS FUNDS AND SPENDING AGENCIES, IN THE AMOUNTS AND FOR THE PURPOSE AS SET FORTH BELOW, FOR THE TOWN OF CRESTONE, COLORADO, FOR THE 1990 BUDGET YEAR.

WHEREAS, the Crestone Town Council has adopted the annual budget in accordance with the Local Government Budget Law, on Dec. 13, 1989, and;

WHEREAS, the Crestone Town Council has made provision therein for revenues in an amount equal to or greater than the total proposed expenditures as set forth in said budget, and;

WHEREAS, it is not only required by law, but also necessary to appropriate the revenues provided in the budget to and for the purposes described below, so as not to impair the operations of the Town of Crestone.

Section 1. That the following sums are hereby appropriated from the revenue of each fund, to each fund, for purposes stated:
