RESOLUTION 1990-1

A RESOLUTION CANCELLING THE MUNICIPAL ELECTION SCHEDULED FOR APRIL 3, 1990 AND DECLARING CERTAIN CANDIDATES ELECTED.

WHEREAS, there is now tentatively scheduled a municipal election to be held by the Town of Crestone on April 3, 1990 for the purpose of electing three persons to the office of member of the Board of Trustees of the Town of Crestone to fill vacancies with respect thereto arising from the expiration of the term of three present office holders,

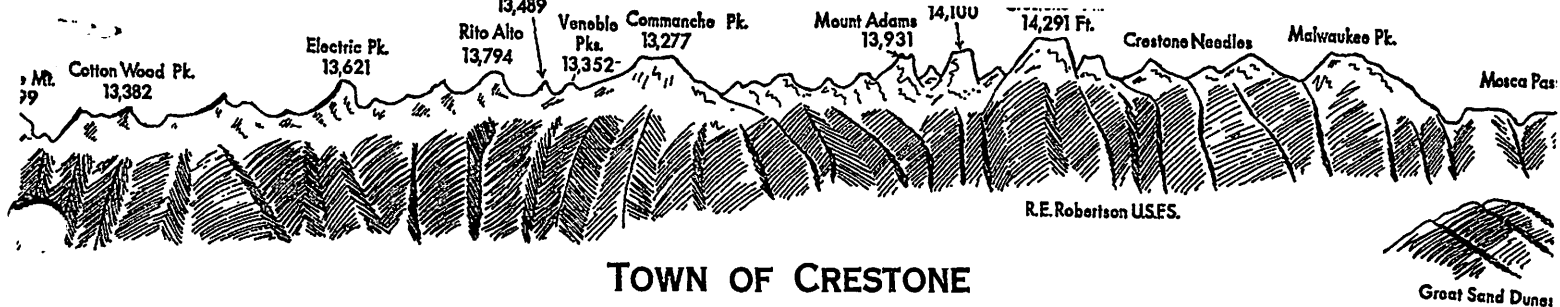
AND WHEREAS, only two candidates, namely C. KIMBERLY SNIDER AND MARIANNE SANDSTROM, have filed nomination petitions, all of such documents having been filed in the form and manner and within the periods of time required by law and by the Town of Crestone Ordinance 1984-2,

AND WHEREAS, said Ordinance 1984-2, adopted by the Town of Crestone pursuant to Colorado Revised Statute 31-10-507: provide that, if the only matter before the voters is the election of persons to office and if, at the close of business on the Friday before the election, there are not more candidates than offices to be filled at such an election, including candidates filing affidavits of intent, the Clerk shall certify such fact to the governing body, and it shall hold a meeting and may cancel the election and by resolution declare the candidates elected,

AND WHEREAS, at the close of business on the Friday immediately proceeding the election, such being March 30, 1990, the only matter before the voters is the election of persons to office and there were not more candidates than offices to be filled at such election,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF CRESTONE AS FOLLOWS:

1. The Board of Trustees finds that the only matter before the voters with respect to the municipal election tentatively scheduled for April 3, 1990, is the election of persons to office and that on the close of business on Friday, March 30, 1990, there were not more candidates than offices to be filled at such election, including candidates filing affidavits of intent.

2. That the Board of Trustees find that there are now three vacancies on the Board of Trustees of the Town of Crestone arising from termination of the term of offices of three persons presently holding such offices.

3. That the Board of Trustees find that there are now only three candidates, namely C. KIMBERLY SNIDER AND MARIANNE SANDSTROM, such being the number less than the number of offices to be filled at such election.

BE IT FURTHER RESOLVED:

1. That pursuant to the terms and provision of said Ordinance 1984-2, the above named two candidates, namely C. KIMBERLY SNIDER AND MARIANNE SANDSTROM be, and they are hereby declared to be, duly qualified to assume the duties of the office of members of the Board of Trustees in the Town of Crestone and are hereby deemed to be duly elected for a four-year term.

2. That notice of such cancellation shall be published, if possible, in order to inform the electors of the municipality, and notice of such cancellation shall be posted at each polling place and in not less than one other place.
