

ORDINANCE 1992-2/

AN ORDINANCE REQUIRING ALL BUSINESSES IN THE TOWN OF
CRESTONE TO OBTAIN A BUSINESS LICENSE.

BE IT ORDAINED by the Board of Trustees of the Town of
Crestone that:

1. There is hereby created an annual business license
requirement for all businesses operating in the Town of
Crestone pursuant to Colorado Revised Statute 31-15-501
as amended, 1991 as amended.

2. The Board of Trustees of the Town of Crestone has
the authority to license, regulate, and tax, subject to any
law of this state, any lawful occupation, business place,
amusement, or place of amusements and to fix the amount,
manner and manner of issuing and revoking licenses issued
pursuant to CRS 31-15-501, 1991 as amended.

The Board of Trustees sets the fee for a business
license to be \$20.00 per year commencing July 1 through June
30 of the subsequent year. The Board of Trustees retains
the right to annually review and set the amount of the
license fee for the forthcoming year.

3. The revenue collected from the issuance of the
business license fees will be set aside for the express
purpose of maintenance and repair of the Crestone Community
Center.

4. This ordinance shall apply to every business in
the town of Crestone, which a person can be employed, that which occupies the
time, attention, and labor of men for the purpose of
gain, profit or profit and corporations organized for the
purpose of doing business...". Colorado Revised Statutes
31-15-510, subsection II (1)(c).

5. Failure to comply with this ordinance is a
misdemeanor and upon conviction thereof, shall result in a

Failure to comply with this ordinance is a misdemeanor and upon conviction thereof, shall result in a fine not to exceed three hundred dollars (\$300.00) and/or imprisonment not to exceed ninety (90) days or both such fine and imprisonment upon the person committing such
