

RESOLUTION NO. 011-2009

A RESOLUTION AMENDING RESOLUTION # 002-2009 ADOPTING A
PRESUMPTIVE FINE/ASSESSMENT SCHEDULE FOR THE
TOWN OF CRESTONE MUNICIPAL COURT

WHEREAS, the Town of Crestone created a municipal court of record by the provisions of Ordinance # 2008-001 and retained a municipal judge licensed to practice law in the State of Colorado in accordance with the provisions of C.R.S. § 13-10 -101, et. seq.; and

WHEREAS, the municipal Judge has recommended that the Town adopt a presumptive fine and assessment schedule as guidance for the Court in levying fines and assessing fees and costs within its jurisdictional limits; and

WHEREAS, the Board of Trustees adopted Resolution #002-2009, Adopting a Presumptive Fine/Assessment Schedule on February 9, 2009, and now believes that such schedule should be extended for further fines and assessments within the Nuisance Code and Code of Offenses;

THEREFORE, be it hereby resolved by the Board of Trustees of the Town of Crestone that the following schedule of fees, fines and assessments be and is adopted and implemented for the Town of Crestone Municipal Court:

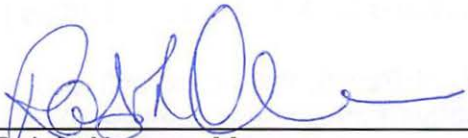
