

RESOLUTION #017-2014

A RESOLUTION AMENDING THE FEE SCHEDULE OF THE TOWN OF CRESTONE, COLORADO ADOPTED BY ORDINANCE 2006-009

WHEREAS, The Board of Trustees of the Town of Crestone established a Comprehensive Fee Schedule on January 9, 2006, to which reference is hereby made; and

WHEREAS, Ordinance 2006-009 states that said schedule may be amended or modified from time-to-time by Resolution of the Town Board of Trustees; and

WHEREAS, the Board of Trustees of the Town of Crestone has established fees for purchase of lots in the Crestone Cemetery that are designated as "green" but has not specified fees for the "Natural Burial Ground" of the cemetery; and

WHEREAS, the comprehensive fee schedule should include fees for both green burials and natural burials; and

WHEREAS, the Board of Trustees of the Town of Crestone established a fee for Medical Marijuana license renewal late fee in Resolution Number 011-2014 "A Resolution Amending the Fee Schedule of the Town of Crestone" on May 12, 2014.

NOW THEREFORE be it resolved by the Board of Trustees of the Town of Crestone, Colorado, that the Fee Schedule adopted by Ordinance 2006-009 be amended as follows:

Section 1. The entire Cemetery Section is replaced with the following:
