TRAIL SYSTEM

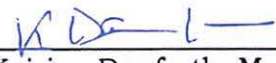

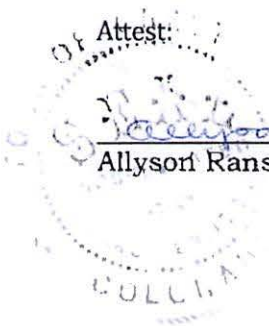

PROGRAM AND OUTDOOR EDUCATION CENTER

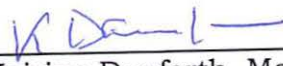

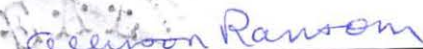
NOW THEREFORE, be it hereby Resolved by the Board of Trustees of the Town of Crestone that:
