

RESOLUTION NO. 013-2021

A RESOLUTION TO CONDUCT A MAIL BALLOT ELECTION AS A PROCEDURE OF THE REGULAR TOWN OF CRESTONE MUNICIPAL ELECTION AND INCLUDE A SPECIAL RECALL ELECTION ON THE SAME BALLOT ON TUESDAY, APRIL 5, 2022, AND AUTHORIZING THE TOWN CLERK AS THE DESIGNATED ELECTION OFFICIAL TO APPOINT ELECTION JUDGES AND ELECTION WORKERS, AND ESTABLISHING THE JUDGES' RATE OF PAY

WHEREAS, The Town of Crestone holds municipal elections every two years; and

WHEREAS, The Town of Crestone must hold a special recall election during the regular election as per C.R.S. § 31-4-502 (4); and

WHEREAS, the Board of Trustees of the Town of Crestone is the governing body for the municipality; and

WHEREAS, the Town of Crestone's 2022 Regular Municipal Election and Special Recall Election to be held on April 5, 2022; and

WHEREAS, it is necessary to conduct said elections as mail ballot elections in accordance with the provisions of C.R.S. § 31-10-907, et seq. ; and

WHEREAS, the Town of Crestone's Board of Trustees appoints the Town Clerk as the Designated Election Official for the 2022 Municipal Election, and for each successive election, for the Town of Crestone; and

WHEREAS, C.R.S. § 31-10-401 requires the governing body of the municipality, or the Town Clerk, if so designated by the governing body, to appoint Judges of the Election at least fifteen (15) days prior to Election Day; and

WHEREAS, C.R.S. § 31-10-408 establishes that Election Judges will be paid not less than five (5) dollars and not more than the maximum amount allowed by statute for payment of judges of the general election of the State of Colorado, as determined by the governing body of the municipality.

NOW THEREFORE, be it resolved by the Town Board of Trustees of the Town of Crestone, Colorado, that

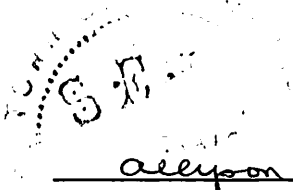
SECTION 1: The Town Clerk is hereby designated as the Election Official and may appoint election workers for each election held by the Town of Crestone, until such Resolution is amended, terminating such designation or designating another person by title.

SECTION 2: The Town Clerk is hereby authorized to appoint the Election Judges for

the April 5, 2022 Crestone Municipal Election and Special Recall Election, in accordance with the Colorado Revised Statutes. The appointed Judges will each receive \$150.00 for their services.
